STEPS AND GUIDELINES

1 - SUBMIT ALL OF YOUR APPLICATION MATERIAL AT LEAST TWO MONTHS (8 WEEKS) & NOT MORE THAN ONE YEAR PRIOR TO YOUR REQUESTED PERFORMANCE DATE

- Due to increased demand, requests for July and August must arrive AT LEAST four months prior

2 - TO BE A PART OF THE PROGRAMME HERE IS WHAT WE REQUIRE:

- That you are a group of at least 20 people, including a minimum of 10 performers.
- That there are NO performers under the age of 5 in the group.
- That you complete & return the enclosed performance application form.
- That you send us RECENT (less than one year old), non-returnable audition material: Videotape (VHS only), DVD or CD

3 - AUDITION REQUIREMENTS

The following criteria have been established by Disneyland® Resort Paris entertainment for selecting performing groups to be a part of the Disney Magic Music Days programme. Your audition material will be evaluated on your group's ability to:

- Play or sing musically, and in tune.
- Display precision in execution of music and /or movement.
- Perform with energy and display a sense of stage presence. Smile!
- Present a well-groomed uniform look - a non-returnable colour photograph must be sent with your application form showing your group in a costume or uniform representative of that to be worn on the day of your performance.

(Dance groups are requested to contact us in advance regarding costume criteria if they require additional information)

3a - All show material performed at Disneyland Resort Paris should be secular; we suggest a varied programme of upbeat, light popular & traditional music. Disney melodies are permitted, however you should remember to avoid using only Disney music!

3b - Audition material should include at least two complete selections (*please avoid solos*) representative of those to be performed at Disneyland Resort Paris.

3c - Groups with choreography or movement in their performance i.e. Marching Bands, Show Choirs, Dance groups etc... must submit a Videotape or DVD recording.

3d - Label all material with the group name and the pieces included.
